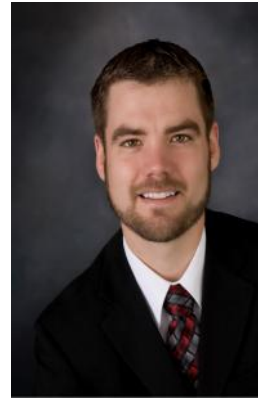


# SWANSON AGENCY AGENTS HONORED FOR 2013 PERFORMANCE
